

Site Wiring	A dedicated, unswitched power line is recommended. The AC outlet should be close to the 2100 POS. Do not use extension cords.

Installing the 2100 POS Workstation

Power Cord

Plug the supplied AC cord into the power adapter mounted into the base. See photo below. Stand the system on its feet and snake the power cable through the cutout in the rear of the base.

Cable Routing

For a neat installation, route the I/O panel cables through the cable tie down clamp assembly. See photo below. Excess cable can be loomed under the 2100 stand and hidden behind the system.

Hard Drive Removal

The 2100 POS System is equipped with one easily accessible hard drives.

To remove a hard drive, follow these steps:

- 1. Shut off all power to the system; unplug the power cord from the AC outlet.
- 2. Remove the single screws on the rear panel and lift off the hard drive access cover.
- 3. Disconnect the HDD cabling.
- 4. Replace hard drive.
- 5. Reconnect the cabling and install the door.
